(a) LIABILITY & RISK RELEASE RELATING TO COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, Alberta Health Services and local governments recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Golden Goal Academy has put in place preventative measures to reduce the spread of COVID-19; however, the Academy cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, participating in soccer activities could increase your risk and your child(ren)’s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by participating in soccer activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 while participating in soccer activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Academy employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)’s participating in soccer activities or participation in Academy programming (“Claims”). On my behalf, and on behalf of my children, I

hereby release, covenant not to sue, discharge, and hold harmless Academy, its directors, employees, contractors, coaches, representatives and volunteers, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Academy, its directors, employees, contractors, coaches, representatives and volunteers, whether a COVID-19 infection occurs before, during, or after participation in any Academy program.
